# Deadline extended

The Return of Banter & Biscuits!

Croydon Council has extended the period for public objections to planned demolition of a detached cottage and excavation of gardens at 2A Addiscombe Avenue to make way for blocks of flats.

The extra time was given in response to CHASE's complaint over the original consultation exercise – first called on 8<sup>th</sup> January with a deadline of 28<sup>th</sup> January – when developers' final plans were only made public on 19<sup>th</sup> January. Consultations should only begin once residents have access to all information.

People living in the area and beyond are urged to share your views on the proposed development by the new deadline of  $10^{\rm th}$

# Taking pride in place

Visitors to the Railway Park have been taking notice of improved accommodation for local amphibians at the eastern end of the popular pedestrian route to Blackhorse tram stop. Living conditions in the newt pond, which was already a bit too shallow for frogs and newts to stay over winter, had been made worse by children throwing stones into the water. In January, volunteers dug the pond to a suitable depth and installed fencing to discourage stone throwing. The return of pond life is eagerly anticipated this spring.

Following an Addiscombe and East Croydon meeting on how the community responds to the Covid-19 pandemic, residents and community groups have come together to run a donation centre at St Mary Magdalene Church, Canning Road on behalf of Croydon Voluntary Action (CVA) and Croydon's Salvation Army.

[Cont'd from page 1] Neighbouring terraced and semi-detached houses would be overlooked by windows facing all directions over three storeys. The 1970s block design would be imposing and jarring in this early-20th Century road and existing parking spaces would be removed from the property to cram in more flats, compounding parking problems on this road. The size and position of the blocks of flats would threaten neighbouring gardens with over-shadowing for most of the year. No plans for sewage and drainage have taken account of the area's aged systems. Threatened removal of trees and hedges would greatly increase noise and air pollution from the tram and high street, affecting all surrounding properties.

#### Why this matters

Even for residents not directly affected by the proposed development, this application

poses the most serious threat to the character of this area within memory.

High-density development at Nihil Place. Grant Road and the new housing estate at Button Court, Everton Road were built on former industrial sites yet they fit into their surroundings and take consideration of the design of neighbouring buildings. But the demolition of a locally well-loved Arts & Crafts style family home to squeeze in two blocks of flats – with five dwellings containing 12 bedrooms accommodating 18 people over three storevs – would set a dangerous precedent for the worst aspects of Croydon's intentions for high density 'intensification' and low-quality design at a high cost to local character and quality of life. If this is allowed to happen on Addiscombe Avenue it would be allowed anywhere else in this area.



#### **Bring your questions**

Recent issues heard by CHASE include questions over the police response to the tragic stabbing of teenager Zaian Aimable-Lina in Ashburton Park, why parking regulations differ from road to road and what coming changes to planning regulations will mean for our area.

#### **Report on activities**

We also would ilike to hear your ideas on what CHASE should be focusing on in the year to come – what would you like to see more or less of in Addiscombe? Since we last met, your committee has:

- Contributed to Covid 19 Mutual Aid efforts, offering support to elderly and vulnerable people by helping with shopping and errands and by collecting food for people in need at Addiscombe's food donation points.
- Provided on-going Neighbourhood Watch support, including delivering crime prevention leaflets and posting new scam warnings online.
- Submitted objections to aspects of property development that would adversely affect our neighbours and our neighbourhood.
- Commented on proposed changes to the Croydon Local Plan that threaten protections on the character and density of our area.
- Helped set up the Addiscombe East Safer Neighbourhood Ward Panel that informs local policing priorities.
